COMMITMENT LETTER & PLAYERS' RULES & REGULATIONS

1. You will not be placed on a roster until this form is returned with payment.
2. NCAA rules will be used and followed.
3. All games will be 7 innings (some games may have time limits – based on fields used)
4. There is no guarantee of equal playing time in this league.
5. All league equipment MUST be turned in at the completion of your team's last game of the season.
6. No fighting! Any fights with another player will be grounds for dismissal from the league.
7. Ejection from a game will result in a one game suspension. Three ejections will result in automatic dismissal from the league.
8. No refunds after **June 12, 2009**. (Games start June 15, 2009.) NO EXCEPTIONS! (You MUST confirm your request for a refund by actually speaking to the director – no leaving phone messages or by email and receiving a reply email confirming your request.)
9. Stealing of any equipment or vandalizing of any playing facility will be automatic grounds for dismissal from the league.
10. If your coach has additional team rules, you are expected to abide by them as well. If you have any problems, approach your coach or the director to discuss them.
